Discussion about how much money to contribute to Shows. Marcie made a motion to give \$300 to the Clover Classic Show. Justin second the motion and motion passed. Mattie made a motion to give \$200 to Spring Fling Show. Justin second the motion and motion passed.

After a brief discussion, Justin made a motion that all the money made from the Silent Auction of the baked goods at the 2015 NCAA Annual Meeting be given to the Cows Hate Cancer Fund. Catherine second the motion and the motion passed.
